Hello, my name is Nicole Ames, and I have been experiencing a significant amount of discrimination, racism, in which my housing rights, has been terribly affected, my civil rights, my privacy rights, and also my parent rights, at certain points. I need help, my properties were illegally taken, I was literally laced with narcotics, psych meds, and poison's. Believe me I know that all seems far fetched, not normal, and sorta psychotic; unfortunately, these statements are not false accusations, they are in-fact very true, and I need assistance with obtaining legal help. Just last month, July 16th 2021, there was a false arrest that I experienced, along with my physical vehicle being moved to a different location, and then illegally towed. these people not only harass, they are fraudulent in various agencies, and departments, such as DMV, I was issued a false suspension on my personal tags, to the vehicle that was actually towed, the people were rude, racist, the guy used foul language and got loud, the woman, was extremely irritated with my presence, and rude as well as racist, fraudulent with corrupt police officers as well. Please help! I have been homeless for years, as a result of lies, real estate fraud, and hate crimes, which I continue to endure, almost literally daily. Please feel free to call me with any questions or concerns. This tow yard is listed under B&G Sons, and these individuals are complete thieves, who will not give the time of day. I tried to show my AAA insurance, with medical included, explaining that I am not a plus member, I am Premier, this is different, because it's much more than just towin, in which these individuals would not listen to me at all.
