Hello, this is Nicole Ames, and my date of birth is [REDACTED] I last physically resided at [REDACTED] located in [REDACTED] My situation currently is being homelessness by force. Illegally I was told to leave my private residence, and several years ago, I was physically attacked, and ambushed inside my home. I have been in the streets, in motels through-out the city and I have even slept in a vehicle for 48 months. I am in need of rapid assistance with housing, in order to get off the streets, then I must obtain some legitimate legal help, to obtain justice. This is extremely awkward, because it's the biological family of my sons, who are harassing, and in law as corrupt individuals. I have also stayed in two shelters, and I got really really sick both times, there has been a lot of force, and harrasement, and honestly, this is a huge injustice that has transpired, as a result of envy, greed, hate, and rape cases, concerning off spring that was shared between these individuals, prostitution rings, and drug and alcohol usage. Basically as a result of their damage, I am suffering. Which is insane, as I do not have anything to do with these sorts of activities, or dilemma's. Of course I am not saying that I am perfect, or that I am a saint; furthermore, I don't pick on people, and lie within the judicial system, to gain things of monetary value, such as private properties, both commercial and residential, vehicles, and a variety of financial institutions, and businesses. What I am trying to do at the present moment, is get inside , versus literally being outside, I am not a circus animal, or someone, who doesn't possess humanity, I have complete sanity , competent, and coherent, extremely functioning and productive, several times these volchers have tried to label mentally ill. I have been discriminated against, treated with really harsh racism, and approached by some evil characters, all of them wanting what I legitimately obtained, mind you without the assistance of these individuals who are involved with the entire situation. Please give me a call to further discuss this matter, these people are really difficult, they break into your homes, and lace your food products, they affect even the material of your personal clothing, creating viruses, infections, skin rashes, and please see below, I was literally sent to the hospital for a situation that had occured in the SaveMart parking lot here in Stockton, at the Hammer Ranch location, I passed out drinking orange juice, and it felt like I had heart problems, shortly after, busted the left side of my head, went

to San Juaquin General hospital , they put me in the psych ward, put me to sleep , cut me open with pocket knife , then literally inserted a rainbow electric eel, inside of me on the right side of my legs, and it's a rattle snake I felt on the left side of my leg. I really want to get to a safe place, away from harm and danger, and then work on seeing my children, who were also affected, as a result of all this madness. I appreciate your attention to this matter, please see contact information listed below. P.S. On July 16th 2021,I was illegally arrested, sent to French Camp jail for three days, hungry in an extremely nasty and disastrous cell, really starving, then for three more days, I was sent to the psych ward, yet again from the jail, these people are ignorant, and savage to do something so harsh, they also stole my vehicle and tried to charge me 727.00, they are illegal in DMV offices, these people do not need to be anyway near my equation, they only bring drama, grievance, and pain. I was at least in my car temporarily. This is really disheartening and sickening, and I can't deal with such evil demonic creatures. Thank You!

I've had many ,many ,years of education, so it's hard to just tell me anything. When you are serious,please reach out to me, I don't need assistance from a murderer, and a drug addict prostitute,that my son Darwin doesn't want anymore!!!!!! My Grandmother told me that she sets things up, with another baby momma,that my son deals with. And they are illegal, and racist, and dangerous. Please notify me for professional, and adequate services. Thanks

I have been literally living on the streets, communicating through computer usage, from the local library in Stockton

Troke Library, the last place I slept was at the bus stop last night, here in Stockton Ca off Hammer. Most of my income goes to eaten, renting rooms, I was just at the Stay Inn for nine days, it's very costly renting rooms. I had a very bad experience at a couple of shelters, such as an individual pulling upon me in a garbage truck, and allowing all of the dirt being swept by the machine, attracted to the cleaning truck, he made sure it got all up in my face, and I had lice and bed bug experiences, along with fungus, even in motel rooms that I own. Because of hate and racism, gay men, sleeping with their family members, and takin their personal frustrations in life, on me.. And I am in need of authentic healthcare, because of serpents inside of me , and the discrimination in the hospital, is absolutly unethical, illegal, applying racism, extremly hateful, and toxic, for those who experiece this type of behaviour and in need of authentic health care services and medicine. So I am not understanding how an individual can implement all of these services,and receive no assistance at all. Please give me a call at [REDACTED] to further discuss, because I want you people out of my complexes, constantly playing games with my life and housing rights, civil rights, and my parental rights were violated as well.

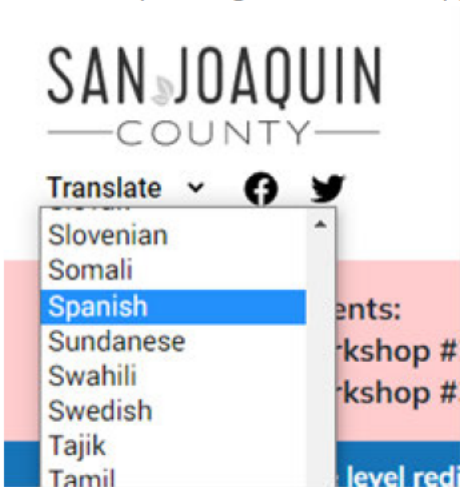
