REASON FOR RECOMMENDATION

On Tuesday, January 26, 2021, the San Joaquin County Board of Supervisors, after a public discussion on establishing a timeline and options for the decennial supervisorial redistricting process, adopted a “Redistricting Advisory Committee” (RAC) as it provides the most transparency and public participation input process. The RAC will make recommendations on district boundaries for the board.

On Tuesday, March 23, 2021, the San Joaquin Board of Supervisors, approved the addition of five alternative members to the RAC. The addition of the alternative members to the RAC will allow for an alternate member to serve in the event that a RAC member is not available.

The Clerk of the Board advertised the additional positions to the RAC and received several qualified applications that are presented for appointment.

FISCAL IMPACT

ACTION TO BE TAKEN FOLLOWING APPROVAL

Upon approval, the appointees so selected by the Board of Supervisors will be required to complete an Oath of Office prior to attending the first meeting and will have 90 days from the date of appointment to complete boards and commissions training required by Resolution R-17-160. The Clerk of the Board will notify the Board Liaison of the Board’s appointment, who will ensure compliance with all other requirements that apply, and readvertise positions not filled by the Board of Supervisors.
