DIVISION 6. AGRICULTURAL ZONES

CHAPTER 9-600 AGRICULTURAL ZONES: INTENT AND ORGANIZATION

9-600.1 TITLE AND INTENT.

Division 6 constitutes the agricultural zones. The intent of this Division is to prescribe use, lot, and structure regulations for agricultural zones within San Joaquin County, consistent with the Land Use portion of the General Plan. The names and intents of the agricultural zones are as follows:

(1) **AG Zone.** The General Agriculture (AG) Zone is established to preserve agricultural lands for the continuation of commercial agricultural enterprises. This zone is intended to implement the General Agriculture land use category of the General Plan.

(2) **AI Zone.** The Agriculture-Industrial zone is established to provide limited dry uses that complement both agricultural and industrial businesses on parcels not considered ideal locations for farming due to site location, irregular shape, or classification of farmland. This zone is intended to implement the Agriculture-Industrial land use category of the General Plan.

(3) **AL Zone.** The Limited Agriculture (AL) Zone is intended to recognize and preserve areas that contain existing concentrations of small-scale agricultural operations and dwellings. This zone is intended to implement the Limited Agriculture land use category of the General Plan.

(4) **AU Zone.** The Agriculture-Urban Reserve (AU) Zone is intended to retain in agriculture those areas planned for future urban development in order to facilitate compact, orderly urban development and to ensure the proper timing and economical provision of services and utilities. This zone also is intended to implement the Agriculture-Urban Reserve land use category of the General Plan.

(5) **ARM Zone.** The goal of the Agricultural Resource Management (ARM) zone is to secure the long-term viability of commercial agriculture properties; this zone is intended to provide areas for the optimal production of commercial agriculture and to protect lands that are best suited for permanent agricultural development by incorporating land uses. The ARM zones also intended to implement General Plan strategies regarding the preservation of agricultural land and the promotion of competitive farmland in the Williamson Act estate.

One of the primary objectives of the ARM zones is to permit only those uses and activities that will not compromise the viability of commercial agricultural operations. The magnitude of any compatible, accessory recreational activities shall be proportional to the size of the parcel. Any future parcel-specific areas needed to separate or reduce conflicting activities shall be located on-site. The Agricultural Resource Management (ARM) zones shall be applied to land that is under Williamson Act lease that is under permanent security agreement and land in the primary data.

This first of all is illegal, in September of 2020, when I first came inside of the Central Valley Housing Office for assistance, my information was suppose to be verified at this time, no more than a month process, and for me personally, when I processed these types of application, I would process them, as I receive the information, for several years I have been personally discriminated against, for a variety of reasons, that are not valid to housing, or any type of assistance, especially when it has to do with your individual livelihood. This is extremely upsetting, as I have completed online applications, the computer gets hacked, and I am unable to submit my information, this goes back to 2013, at another agency, during an interview for part time work, as I stated because of a shooting I ended up losing memory, and it seems that I was taken completely advantage of. There Has been many people playing games with my personal life, my personal finances, and harassing me every chance they recieve. Being that I cannot obtain justice through the local police department, or advocacy agencies, I simply just have t stand my ground and protect myself, from low life drug addicts apparently, that hate my father Mr. Godfrey, there are many people that I no longer like for a variety of reasons;however, it gives none of you involved the right to harass me through services, and agencies that I actually created, funded and implemented. Another issue, Visionary Home Builders, my sons Anthony Adams prostitute and mother of five of his children, just took my agency and did as they choose, these people many of them, don't even have green cards, meaning they are illegals, then I also deal with the hate and harassment from local agencies, such as Victims witnesses, in which I created, and funded for the sake of an abused victim in the past. Nonetheless, I am not able to receive assistance because of drama, between individuals, that has nothing to do with me , as well as literally having serpents inserted inside of me, because of hateful, low life, no moral compass having people. This goes against the conduct and work ethics, that's allowed by law, but the law is not even legitimate law. Ive been homeless and living like this for several years illegally because of racism, prostitutes, and hate towards my father who hasnt done anything to these people, that they didnt want done, my sons sex addictions, and his affiliates cleaming out agencies, when funds are desperatly needed to clean communities. I don't support drug habits, nor do I enable addicts to get drugs from my hard earned money and properties. To This day I am still at the bus stops, because of people not caring, and playing games with my life. When do I see justice, and when do these people get out my properties, so that I can go home. If this had been myself and my father , we would have been arrested, this is certainly an injustice, many attempts of homicide towards my life, and just thrown out to the apes, sheeps , wolves, and scavengers. Completely racist, ignorant, and unfair. I've contacted the victims witness program for years, completed my application, and received nothing, myrape kit was thrown out in the parking lot, a racist nurse hurt me badly, just doing something simple like drawing blood. All I have constatly endured, is attacks, false imprisonment, theft on a major scale, rape, abuse, tauting, bullying towards my daughters, brainwashing towards my daughters, nothing godd at

all, and I have submitted everything that was needed, to housing, central valley housing, many , many online applications to affordable housing, even to my own project, Visionary Home Builders, so where is my justice, certainly there isnt peace left in me, after this. In and out of three shelters, laced, harassed, and discriminated against, was sick, then I go to pay rent in a legal motel I own on Plymouth Rd, and harassed by a huge pacific islander he/she from Anthony's group of racist people, that I simply will no longer tolerate. I don't care about no one's personal feelings, especially in these agencies that were created for specific reasons, of aiding those in need of the services, and when I contact these people, all I have gotten is my legal rights, civil rights, housing rights, humanity rights, women's rights, parental rights, are all violated because of racism, and hate, envy and greed, which has caused others in my personal homes, and me being on bus stops since September 5th, 2020. Where is my justice???????????????????? I copied a lot of individuals on this email, to reach these agencies that are not doing their jobs, and to express to those involved, how you people have ruined a part of me forever. Because of racism, harsch forms of discrimination, in a variety of ways, lack of professionalism, and hatred. None of which has anything to do with adequate services, to those in need of affordable housing assistance, which is the point of each agency created and funded.
