RESCISSION OF TITLE 2, DIVISION 1, CHAPTER 1

The Board of Supervisors of the County of San Joaquin ordains as follows:

SAN JOAQUIN COUNTY CODE OF ORDINANCES, TITLE 2, DIVISION 1, CHAPTER 1 is rescinded as follows effective 30 days from the date of adoption pursuant to Government Code Section 25123 conditioned upon the Board of Supervisors approval of a Resolution adopting new Supervisorial District boundaries pursuant to Elections Code Section 21500 *et seq.*:

~~The County of San Joaquin is hereby divided into supervisorial districts. The supervisorial districts hereinafter numbered are hereby established, and the descriptions of their boundaries shall be as set forth in this chapter. For the purposes of this chapter, references to "CT" shall mean "Census Tract," as that demographic unit is established by the United States Bureau of the Census for the 2010 Census as described by maps and publications of the Bureau. References to "Block Group" and "Block" refer to those demographic units as established by the United States Census Bureau for the 2010 Census as described by maps and publications of said Bureau.~~
