The following accurately describes the San Joaquin County supervisorial district boundaries based on the 2020 federal decennial census pursuant to Elections Code §21500 *et seq.* adopted by the San Joaquin County Board of Supervisors on December 7, 2021:

SAN JOAQUIN COUNTY SUPERVISORIAL DISTRICTS

The County of San Joaquin is divided into five supervisorial districts. For the purposes of describing the supervisorial district boundaries, references to "CT" shall mean "Census Tract," as that demographic unit is established by the United States Bureau of the Census for the 2020 Census as described by maps and publications of the Bureau. References to "Block Group" and "Block" refer to those demographic units as established by the United States Census Bureau for the 2020 Census as described by maps and publications of said Bureau.
