**SAN JOAQUIN COUNTY BOARD OF SUPERVISORS ANNOUNCES THE
REDISTRICTING ADVISORY COMMITTEE AND EXTENDS THE DEADLINE TO
SUBMIT APPLICATIONS ON PREVIOUSLY ANNOUNCED POSITIONS**

Application Deadline is February 26

San Joaquin County –February 2, 2021 – On Tuesday, January 26, 2021, the San Joaquin County Board of Supervisors, after a public discussion on establishing a timeline and options for the decennial supervisorial redistricting process, adopted a “Redistricting Advisory Committee” (RAC) as it provides the most transparency and public participation input process.

The RAC will make recommendations on district boundaries for the board. There will be a total of 10 members representing a broad swatch of community interest throughout the county. To that end, two members from each district will be able to represent those interests. As a part of the process, a number of public hearings and workshops will be held between the Redistricting Advisory Committee and the Board of Supervisors to engage in that significant public input process.

Additionally, the Board of Supervisors is seeking volunteers to serve on various other boards and commissions. The deadline to submit applications for the new and previously announced positions is **Friday, February 26**. The Board of Supervisors will consider qualified applications, received on or before the deadline, at the Board meeting of March 23, 2021.

All members appointed by the Board of Supervisors will be required to attend training. Training dates and registration information will be provided by the Clerk of the Board upon appointment.

• **Agricultural Advisory Board – 2 Positions**

- **Assessment Appeals Board #2 – 2 Positions**

Qualified applicants must have a minimum of 5 years professional experience in this State as one of the following: certified public accountant or public accountant; licensed real estate broker; attorney; property appraiser accredited by a nationally recognized professional organization.

If appointed, appointees are required to submit a Form 700 – Statement of Economic Interest.

- **Children’s Services Coordinating Commission – 2 Positions**

- **Community Action Board – 1 Position**

Members must be a resident of San Joaquin County.

- One (1) Fourth Supervisorial District Representative, Position No. 2404

- **Council for Quality Education and Care of Children – 4 Positions**

All new applicants must complete a Supplemental application prior to being appointed and must attend one Council for Quality Education and Care of Children regular meeting within the 3 months *prior* to being appointed to the Council. Qualified applicants must live, work, or receive childcare services in San Joaquin County.

- One (1) Community Representative, defined as a person who represents an agency or business that provides private funding for child care services, or who advocates for child care services through participation in civic or community-based organizations but is not a child care provider and does not represent an agency that contracts with the California Department of Education (CDE) to provide child care and development services. Position No. 2502.3
- One (1) Consumer Representative, defined as a parent of person who receives or who has received within the past 36 months, child care services. Position No. 2503.2
- One (1) Discretionary Representatives, Position Nos. 2504.1
- One (1) Public Agency Representative, Position No. 2505.1

- **Garden Acres Community Center Advisory Board – 1 Position**
Qualified applicants must be 16 years of age and older and reside in the Garden Acres Community Center service area.

- **Harmony Grove Church Advisory Council – 1 Position**
 - One (1) Member, Position No. 3201.8, who has a historical interest in Harmony Grove Church.

Members of the Committee shall be residents of San Joaquin County and reside in the supervisorial district for which they are appointed to represent.
