#### **Dissertation:**

<u>Teacher Language and Tradition: A Hermeneutic Analysis of California</u> <u>Classroom Diversity.</u>

The study focused on teachers in urban, suburban and rural multicultural classroom settings throughout Northern California. Through the language teachers used to describe their experiences, the study showed how teachers dealt with the issues in classrooms with large populations of diverse students and how their own traditions impacted their teaching. The study then identified the implications of teacher embeddedness in their language and traditions for the culturally diverse students whom they taught. The findings of this study could be applied for further research, program implementation and curriculum development.
